# Introduction

This booklet contains the mark schemes for papers 1 and 2 of the Optional level 6 tests in mathematics.

Each mark scheme was devised after trialling the tests with pupils and contains examples of some frequently occurring correct and incorrect answers given in the trials. Each mark scheme indicates the criteria against which judgements should be made.

The last section of this booklet provides information about interpreting the scores from the tests.

## General guidance

### *The structure of the mark schemes*

The marking information for each question is set out in the form of tables, which start on page 12 of this booklet. The 'Q' column on the left-hand side of each table provides a quick reference to the question number. The 'mark' column indicates the total number of marks available for each question part.

On some occasions the symbol (U1) may be shown in the mark column. The 'U' indicates that there is a *Using and applying mathematics* element in the question. The number, 1, shows the number of marks attributed to using and applying mathematics in this question.

The 'correct response' column may include two types of information:

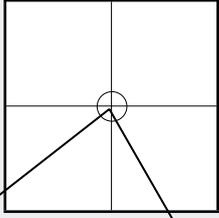
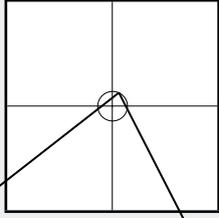
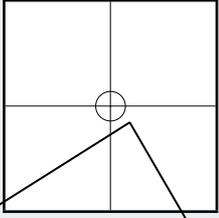
- a statement of the requirements for the award of each mark, with an indication of whether credit can be given for correct working
- examples of some different types of correct response.

The 'additional guidance' column indicates alternative acceptable responses, and provides details of specific types of response which are unacceptable. Other guidance, such as the range of acceptable answers, or when 'follow-through' is allowed, is provided as necessary.

### *Applying the mark schemes*

In order to ensure consistency of marking, the most frequent procedural queries are listed on pages 6 and 7 along with the action the marker will take. This is followed by further guidance relating to the marking of questions that involve money, time and other measures, coordinates, probability and algebra. Unless otherwise specified in the mark scheme, markers should apply the following guidelines in all cases.

Any correct method of setting out working, however idiosyncratic, should be accepted. Provided there is no ambiguity, condone the continental practice of using a comma for a decimal point.  |  |
| <i>There appears to be a misreading affecting the working.</i>                                  | This is when the pupil misreads the information given in the question and uses different information without altering the original intention or difficulty level of the question. For each misread that occurs, deduct one mark only.   |  |
| <i>No answer is given in the expected place, but the correct answer is given elsewhere.</i>     | Where a pupil has shown understanding of the question, the mark(s) should be given. In particular, where a word or number response is expected, a pupil may meet the requirement by annotating a graph or labelling a diagram elsewhere in the question.  |  |
| <i>The response in the answer box is wrong, but the correct answer is shown in the working.</i> | <p>Where appropriate, detailed guidance will be given in the mark scheme, which markers should follow. If no guidance is given, markers will need to examine each case to decide whether:</p> <ul style="list-style-type: none"> <li>the incorrect answer is due to a transcription error</li> <li>in questions not testing accuracy, the correct answer has been given but then rounded or truncated</li> <li>the pupil has continued to give redundant extra working which does not contradict work already done</li> <li>the pupil has continued to give redundant extra working which does contradict work already done.</li> </ul> | <p>If so, the mark should be awarded.</p> <p>If so, the mark should be awarded.</p> <p>If so, the mark should be awarded.</p> <p>If so, the mark should not be awarded. | <i>The pupil's answer is correct but the wrong working is shown.</i>   | A correct response should always be marked as correct unless the mark scheme states otherwise.   |
| <i>The pupil has made a conceptual error.</i>  | <p>In some questions, a method mark is available provided the pupil has made a computational, rather than conceptual, error. A computational error is a 'slip' such as writing <math>4 \times 6 = 18</math> in an otherwise correct long multiplication. A conceptual error is a more serious misunderstanding of the relevant mathematics; when such an error is seen no method marks may be awarded. Examples of conceptual errors are:</p> <ul style="list-style-type: none"> <li>• misunderstanding of place value, such as multiplying by 2 rather than 20 when calculating <math>35 \times 27</math></li> <li>• subtracting the smaller value from the larger in calculations such as <math>45 - 26</math> to give the answer 21</li> <li>• incorrect signs when working with negative numbers.</li> </ul> |
| <i>The correct response has been crossed out and not replaced.</i>   | Any legible crossed-out work that has not been replaced should be marked according to the mark scheme. If the work is replaced, then crossed-out work should not be considered.  |
| <i>More than one answer is given.</i>  | If all answers are correct (or a range of answers is given, all of which are correct), the mark should be awarded unless prohibited by the mark scheme. If both correct and incorrect responses are given, no mark should be awarded.  |
| <i>The pupil's answer correctly follows through from earlier incorrect work.</i>                             | Follow-through marks may be awarded only when specifically stated in the mark scheme, but should not be allowed if the difficulty level of the question has been lowered. Either the correct response or an acceptable follow-through response should be marked as correct.  |
| <i>The answer is correct but, in a later part of the question, the pupil has contradicted this response.</i> | A mark given for one part should not be disallowed for working or answers given in a different part, unless the mark scheme specifically states otherwise.   |
